New Restaurant in Barnstead

Paul and Kim Diomede, along with their real estate partner, Julian Pecorino, have opened their second restaurant, The Lower East Side, on Rte. 28 in Barnstead. Located in the former JJ Goodwin's, the new pub is a very welcome addition to the area. The property required significant renovations, which the team has been handling since January, finally opening in late September.



The pub is located on the 'lower east side' of the

building, which inspired the name and which also pays homage to the Lower East Side of Manhattan, where Paul and Kim lived for many years. The pub is a cozy, casual, and classy rock & roll bar, decorated with vintage photos of musicians and artists and classic *Rolling Stone* magazine covers. The delicious menu includes a nice selection of appetizers and salads, as well as close to a dozen hearty sandwiches and several entrees.

In addition to the tasty food, the pub also features two pool tables, and eight TVs for watching your favorite sports games. Within the next few months they plan to host live music nights, along with a weekly trivia night, music bingo, and possibly a pool league.

In Spring 2025, Paul and Kim plan to open the upstairs dining room, which will be known as The Upper West Side. Upstairs dining will offer classic American bistro fare including steak, lobster, New England seafood and the like. Next summer there will also be outdoor seating and outdoor live music.

The restaurant currently employs 14 staff, with Kristen Piper serving as lead chef and Leah Liouzis managing the bar. The Lower East Side is currently open 6 days a week (closed on Tuesdays) from 4pm to 11pm, with a limited dinner menu from 8pm to 11pm. By the end of this month, they plan to open for lunch.

In mid-November, Paul and Kim will host a fundraiser for The Scenic Theater. For anyone who dines at the pub and has tickets to the upcoming Pittsfield Players production of "Into The Woods," twenty percent of proceeds will be donated to the theater. They hope to host other fundraisers in the future.

Already drawing a great following of people who enjoyed JJ Goodwin's, The Lower East Side has quickly established itself as a warm, inviting and fun spot for family and friends to gather over great food and drinks. Plan to get over there soon. It will definitely become your go-to for a great time. *MP Christakos*



Should New Hampshire increase funding for childcare providers?

Pearl, R, NH Senate: I am open to increasing childcare opportunities as long as it does not increase the tax burden even further on our working families in New Hampshire.

Roberts, D, NH Senate: Yes! I believe New Hampshire should increase funding for childcare providers. Access to affordable, quality childcare is essential for working families and supports the economic well-being of our state. Investing in early childhood education aligns with our constitutional values, which emphasize the importance of education for all citizens. By supporting childcare providers, we not only help parents participate fully in the workforce but also invest in the foundational education that prepares our youngest residents for future success. Enhancing funding for childcare reflects our dedication to both families and the long-term prosperity of New Hampshire.

Allard, I, NH House: Childcare has become a critical element of workforce development and sustainment. However, these are elementally private business decisions, with few connections to the New Hampshire tax base. Covid-related federal funding is drying up, and the pernicious inflationary spiral is still with us. The only way to increase funding is to tax more, and that is something the majority of residents say, clearly, they do not want. Does the aging population of our state want their taxes increased to pay into a childcare system they have no connection to? What the state should do is facilitate the establishment and sustainment of these small businesses. The state can streamline licensing, health and safety inspections, and training programs for caregivers and other staff. The state should incentivize early childhood education training within the university system to encourage more students to make this career choice. The state could also facilitate small business loans wherever the need for these establishments is most critical.

Aures, R, NH House: This is a typical political question asking to provide funding to solve a problem without any parameters. I am not in favor of creating a massive government subsidy with no plan for funding and minimal guidelines not to overburden the provider with excessive legislation. This problem has already been burdened by the excessive pandemic funding that now is evaporating.

Kelly, D, NH House: Our children are our future.

We need to provide our children with every opportunity to be successful adults. Currently, families often entrust their most valuable asset, their children, to workers who do not even earn a livable wage. If there is an opportunity for us to start to rectify this scenario, we need to explore all options to accomplish that.

Schroth, D, NH House: As far as funding for childcare providers, the state is probably shirking their responsibilities on proper funding in this department too.

Wood, R, NH House: Childcare costs in New Hampshire are a significant issue, and efforts are being made to make it more affordable and accessible. Some areas I would like to explore are tax credits for working families and incentives for childcare providers. Legislative actions along these lines were taken in 2024: HB1056: Allows more flexibility in childcare service hours. HB1407: Balances increasing childcare center capacity with maintaining sufficient staff for child safety. HB1573: Revises licensing and monitoring for residential treatment programs. HB1584: Increases the number of children allowed in private home daycares. SB478: Simplifies regulations by eliminating child care employment eligibility cards. These measures aim to reduce costs, increase capacity, and maintain high-quality childcare standards.

Should New Hampshire guarantee the right to access abortion before 24 weeks?

Pearl, R, NH Senate: I believe it would be wrong to rewrite New Hampshire's Constitution to include abortion language and I believe New Hampshire has already achieved consensus on the abortion issue.

Roberts, D, NH Senate: I believe in upholding individual liberties and protecting personal medical decisions from government interference, principles consistent with our constitutional protections of privacy and personal rights. Guaranteeing the right to access abortion before 24 weeks ensures that women can make critical healthcare decisions in consultation with their medical providers. While I respect the diverse views on this sensitive issue, I support policies that safeguard women's autonomy over their own bodies, in line with our commitment to personal freedom and constitutional rights.

Allard, I, NH House: Current New Hampshire law does exactly that, and it should not be changed. Our present law results from a truly bi-partisan effort to strike a balance. The result is one of the country's best state statutes on this subject. Only an amendment to the state Constitution could "quarantee" abortion access, and that is a high bar to achieve. An amendment requires a two-thirds vote in both the House and the Senate, the governor's signature, and then a two-thirds vote by the NH electorate. In our polarized society, that would be a very difficult standard to reach. I believe the current law ought to be time tested to see if it meets the needs and desires of New Hampshire's stakeholders before seeking a change.

Aures, R, NH House: NH already guarantees a woman access to an abortion up to 6 months - 24 weeks, and longer if the mother's life is in danger... If NH streamlined the adoption process women might take advantage of allowing another family to raise that precious child. The adoption process in America has, over time, made it much too difficult for the average hopeful parents who can't afford overseas adoption fees.

Kelly, D, NH House: The decision to have or not have an abortion before 24 weeks is a privacy issue between the woman and her family and medical advisors. It is not my decision; it is not the state's decision; it is the mother's decision. NH needs to continue to guarantee the right to access abortion before 24 weeks. I support codifying into NH law, which passed in the House last session but failed in the Senate.

Schroth, D, NH House: Abortion is healthcare for women, anytime. I would never interfere with such a complicated and personal issue.

Wood, R, NH House: To guarantee the right to access abortion before 6 months means a change to the state constitution. I don't see it happening. Most constituents feel that 6 months is excessive for an abortion without a medical reason, which will always be covered. At some point, the child must have a guaranteed right to live.

Should New Hampshire's government do more to address climate change?

Pearl. R, NH Senate: No, I do not believe we need to expand the many laws that New Hampshire already has in place to improve the state's clean air and clean water.

Roberts, D, NH House: Yes! I believe that addressing climate change is both an environmental necessity and an economic opportunity for New Hampshire. Our state constitution recognizes the importance of conserving and protecting our natural resources for future generations. By taking proactive measures to combat climate change—such as investing in renewable energy and energy efficiency—we honor this constitutional commitment. These actions can also stimulate economic growth, create jobs, and ensure a healthier environment for all residents. It's imperative that our government leads in safeguarding our environmental heritage while promoting sustainable economic development.

Allard, I, NH House: Every level of government and every individual ought to do more to mitigate the effects of climate change. I say that while recognizing that New Hampshire is one state among fifty, and a small one at that. Genuine mitigation can only come from national and international efforts to reduce greenhouse gases and isolate carbon. Here in New Hampshire we must take steps to limit effects from sea level rise along our fourteen miles of coastline and into the Piscataqua Basin. Even in this heavily forested state, we should plant carbon-consuming trees in available public spaces. We should encourage and incentivize reforestation of private lands. Where feasible on both public and private lands, the state government needs to aggressively encourage alternative energy developments—while remaining mindful of the priceless value of our landscapes. Building code revisions need to address alternative energy inclusion for most new construction. And it is long past time to institute container redemption, as well as mandating all possible recycling. We should also revitalize hydropower from existing dams now idle, and prepare for the eventual shutdown of the Seabrook nuclear facility.

Aures, R, NH House: Our senators and representatives in Washington, DC should be requesting China and India to clean up their toxic environment. If they do, it will benefit NH and the planet much more than anything we can do. NH is less than .5% of the United States, nothing we could conceivably do by law can possibly have a measurable effect on the climate. We can continue to keep the NH economy among the top 3 economies in our nation by keeping regulations to a minimum. Three Mile Island is slated to be restarted as our nation's need for energy grows. Nuclear power is the cleanest energy source at this time, so we should start building nuclear facilities. Doing so would eliminate the unfriendly environmental windmills that kill countless birds and soon will be killing marine animals while destroying our beaches.

Kelly, D, NH House: The ski industry is an example of how climate change affects our state and reduces our state's revenues. When we don't have snow, we don't have out-of-staters spending money at our restaurants, stores and hotels, or paying our meals and hotel taxes.

The state needs to add more incentives for consumers to be more energy efficient. Some simple examples are to expand net metering for those who invest in solar energy, provide rebates to those who buy electric vehicles, and do what several of our neighboring states have done and provide an incentive for bringing your own bags to the grocery stores.

The state needs to ramp up its educational component for students, to teach them the effects of climate change and the simple steps they can take to make meaningful changes for the good of the environment and its future.

Schroth, D, NH House: Changes Everything - We need to rid ourselves of the Republican majority in the statehouse, who are pretty much anti-science and unintelligent when it comes to this issue; must be lack of oxygen.

Did you know you are only as resilient as your infrastructure? Pittsfield and Chichester have three HIGH HAZARD dams in a row. These dams are old and not built for what is coming. This issue is what I have been attempting to get our local and state officials to listen to me about!

What is Suncook Lake gonna look like, when it flows through our towns?

No. Republicans in the statehouse are more interested in taking away human and minority rights and focusing on who is screwing who. At your service!

Wood, R, NH House: I am not a big fan of groupthink and how correlations without pure science can relate apples to oranges. I was trained, tested, and encouraged always to suspect any result that I was expecting! A quick search brought out a paper from UNH that "New Research Reveals Climate Change Impact on Forests May Be Lower Than Expected!" Enough said. NH is dependent on fossil fuels, has no direct pipeline, limited electric delivery, propane delivery is only allowed by port using the most antiquated shipping (we tried to change this by vote but failed), 18 miles of coastline with the Isles of Shoals only 6 miles off the cost, wind patterns with an average too low to generate any output, a sun inclination during the winter months that is too

inefficient, and finally, the only power generated in the state is nuclear, which has a low (no) greenhouse gas fingerprint. I would encourage the House to work more on the cost issues and solutions that work for NH. Our energy cost is the highest in the country!




NH Business Tax Revenue 2015 vs 2023 \$551,700,000 2015 2023 When NH businesses are taxed LESS, revenue for public school education grows.

Cook's Corner

Creamy Chicken Enchilada Soup

I realize our sights are turning toward Thanksgiving, as the calendar reminds us, that lovely holiday is right around the corner. But if, like me, you're a little

over everything "pumpkin spiced," this is our time to tuck in a super easy, very tasty "Mexi" dish. This soup (it's more like a stew) is DELISH. If you can, it's best to make this with shredded rotisserie chicken, it adds a lot more flavor (Sam's Club sells a large rotisserie for \$5, unbeatable price). But if that's not an option, just boil or bake some boneless chicken breast and shred it. Make this one soon and do not skimp on the toppings. The toppings make this bowl of wonderfulness zing! I usually serve this with a side of salad and mini flour tortillas with cheese and scallions. Ole, ole mi amigos!!have pumpkin spiced coffee in the morning, if necessary.

1 TBSP vegetable oil

1 cup chopped onion

3 cloves garlic, minced

5 cups chicken broth

1 (15 oz) can diced tomatoes, do not drain

1 (4 oz) can chopped green chiles

6 corn tortillas, chopped

2 tsp chili powder

1 tsp ground cumin

3 cups shredded, cooked chicken breast (rotisserie chicken works well here)

4 oz low fat cream cheese, softened

1 cup shredded Cheddar cheese

1 & ½ tsp cornstarch

Toppings: fresh chopped cilantro, sour cream,

jalapenos, guacamole

Heat oil in a large pot over medium heat. Add onion and cook, stirring occasionally, for about 3 minutes. Add garlic and cook another 1 minute. Add broth, tomatoes (with juices), chiles, tortillas, chili powder and cumin. Stir well; bring to a boil. Reduce heat to a simmer. Cover and cook on a low simmer for 20 minutes.

Ad the chicken and cream cheese, stirring until cheese melts. Remove from heat.

Combine Cheddar and cornstarch in a bowl, toss well to coat the cheese. Gradually add the cheese to the soup, stirring along the way until cheese is melted, about 1 to 2 minutes.

Serve with suggested toppings. M.P. Christakos




